FLORIDA DEPARTMENT OF HEALTH IN OKALOOSA COUNTY ANNOUNCES COVID-19 VACCINATION FOR MAY 24-29

FORT WALTON BEACH, Fla.— The Florida Department of Health in Okaloosa County (DOH-Okaloosa) is partnering with Okaloosa County Emergency Medical Services to offer COVID-19 vaccinations to anyone 12 years of age or older (Pfizer-BioNTech) or 18 years of age and older (Johnson & Johnson). The vaccine is free for everyone. Appointments are recommended but people may come to any event without an appointment.

Any individual who is not at least 18 years of age by the day of their vaccination appointment must be accompanied by a parent/guardian to the vaccination clinic. Unaccompanied minors cannot be vaccinated and will be turned away from the vaccination clinic.

DOH-Okaloosa still has appointments available for vaccination events the week of May 17-22.

Registration for vaccination events May 24-29 will open at 7 a.m. on May 15.

COVID-19 infections are here to stay. But **DID YOU KNOW?** Any person who is fully immunized against COVID-19 will not need to quarantine or be tested after exposure to a known case of COVID-19. People are considered fully vaccinated:

- 2 weeks after their second dose in a 2-dose series, like the Pfizer or Moderna vaccines, or
- 2 weeks after a single-dose vaccine, like Johnson & Johnson's Janssen vaccine

All individuals being vaccinated must show a valid picture ID. Minors can be identified by their parent/guardian, if they do not have a valid picture ID. This can include, but is not limited to, a passport, driver's license, or military identification card.

A second dose of the Pfizer COVID-19 vaccine is required 21 days after the first dose. <u>Learn</u> more about mRNA vaccines and how they work.

Individuals receiving the vaccine must complete a consent form. This is available on our <u>website</u>. For those that cannot access the forms in advance, a paper copy will be provided at your appointment time. **A consent form is required for each dose of the vaccine.**

Individuals receiving the vaccine are asked to wear short-sleeve shirts and remove any jackets/coats when arriving.

The Centers for Disease Control and Prevention advises individuals to be monitored for at least 15 -30 minutes after receiving the vaccine. Individuals will be directed to a waiting area to park or sit and should plan accordingly.
