MINUTES

Purpose: Engage Okaloosa County community members in a health improvement process through an open, two-way dialogue to reduce the number of adults engaged in substance use.

Opening – Petra Maddens

- Petra Maddens opened the meeting and welcomed attendees. She also shared results from the Community Engagement Survey from the previous meeting.
- Minutes from the January 11, 2023 meeting were reviewed and approved.
- Petra and Emily Pickens shared updates from the Substance Use Strategy meeting. The
 purpose of the meeting was to determine how each OCHIP group would operate to
 address substance use.
 - Attendees determined that the OCHIP Champions will meet quarterly to share progress updates across OCHIP groups to foster collaboration.
 - Additionally, Emily will share monthly emails that include dates of all OCHIP groups for all those interested in attending other group meetings. The <u>DOH</u> webpage has also been updated to list OCHIP meeting information including minutes, upcoming meetings, and updates.

Action Plan Updates – Kylee Gallavan and Deb Willis

- Christine Syfrett and Katherine "Kat" Beedie opened the meeting by providing an opioid presentation to the group.
 - o They presented data on prescription overdoses, deaths, and Naloxone administrations in Okaloosa County and across the state of Florida.
 - The presentation slides and the map of Naloxone administration in Okaloosa County will be shared with the meeting minutes.
- Emily reviewed the list of compiled resources for the services rack card that were provided by OCHIP group members. She requested edits from the group.
 - Housing
 - Kylee stated the Freedom Life Compass website has a list of housing options which include Saving Grace, Path of Grace, House of Hope, and Freedom House. Kylee shared Freedom Life Compass can be listed under Substance Use Support, but that Freedom House should be under housing.
 - Substance Use
 - Petra shared Lakeview Center is now called Lifeview Center.

- Kylee stated Project Hope and Saving Grace are a year-long program with no barriers to access.
- Food Assistance
 - Emily stated she recently received the list of food distribution sites from the local ministerial board and will update the document.
- Education
 - Anamaria shared there may be free classes through the public library system. The group believes this may involve Okaloosa Technical College.
 - Kylee suggested asking NWFSC if they provide any free resources or programs that can be included on the rack card.
- Health and Healthcare
 - Emily stated more information is needed from Ascension Sacred Heart on clinical screenings. More information is also needed from local hospitals on what they provide.
 - Emily also shared that 90 Works will need to be added to this section.
 - Kylee added that Crossroads Center should be added as well.
- Emily stated she will send a draft of the rack card out via email. OCHIP members will have a specified amount of time to suggest edits and additions before finalization.

Open Discussion - All

- Petra announced the Okaloosa County Resources Fair will be held on April 4th from 12:00PM to 6:00PM at Trinity United Methodist Church in Fort Walton Beach. The purpose of the event is to have on-site services readily available for residents to utilize or sign-up for. - Kylee proposed that the Healthy Behaviors OCHIP group meets monthly rather than bimonthly. There were no objections.

According to the CDC...

The drug overdose epidemic continues to worsen in the United States.

Drug overdoses, both fatal and nonfatal, continue to impact our nation.

Overdose deaths remain a leading cause of injury-related death in the United States.

Most overdose deaths involve opioids.

Overdose deaths accelerated during the COVID-19 pandemic.


Deaths involving synthetic opioids (such as fentanyl) and stimulants (such as cocaine and meth) have increased in recent years.

Okaloosa Substance Use Dashboard, FLHealth CHARTS




Total Opioid Death Counts, Florida Circuit One Counties, 2016-2020, N=1000






Rate of Opioid Deaths (per 100,000 population), Florida Circuit One Counties, 2016-2020, N=1000






Rate of Opioid Rx (per 1,000 population), Florida Circuit One Counties, 2017-2021



2018-2019 DOH-Okaloosa Injury Prevention Group partnered with local hospitals and EMS to standardize opioid treatment and prescribing policies in Okaloosa County (e.g., Alternative Treatment Options, searching E-FORCSE for "frequent flyers", and limiting duration of opioid therapy).

Signs of acute opioid overdose

Small, constricted "pinpoint pupils"

Falling asleep or losing consciousness

Slow, weak, or not breathing

Choking or gurgling sounds

Body limpness

Cold and/or clammy skin

Discolored skin (especially the lips and nails)

What is Naloxone?

"Naloxone is a life-saving medication that can reverse an overdose from opioids- including heroin, fentanyl, and prescription opioid medications- when given in time."

Reverse opioid overdose with Naloxone.

How Does Naloxone Work?



Naloxone is small and easy to carry and comes in two forms: a prefilled nasal spray and an injectable.


Naloxone binds to opioid receptors and therefore blocks the effects of opioids


Naloxone won't harm someone if they're overdosing on drugs other than opioids (or aren't experiencing any drug overdose), so it's always best to use it if you think someone is overdosing

Naloxone can restore normal breathing within 2 to 3 minutes in a person whose breath has slowed, or even stopped, as a result of opioid overdose


More than one dose may be required

Total EMS Naloxone Administration Okaloosa County vs. Florida







EMS Naloxone Administration, "Found To Be" Categories, Okaloosa County, 2013-2021, N=2520




Naloxone Administration by Age Range, Okaloosa County, 2013-2021, N=2520
