Opening – Emily Pickens

- Emily Pickens opened the meeting and welcomed attendees. She reviewed the meeting's purpose and agenda.
- Caitlyn Golding shared feedback from the Community Engagement Survey from the previous meeting.
- Minutes from the February 22, 2023, meeting were reviewed and approved.

Action Plan Updates – Sgt. Jessica Trimboli and Danielle Wilson

- Danielle Wilson provided an update on the Handle with Care video progress. She stated the video has been shot and the videographer is in the process of editing it.
 - The video should be completed before the next meeting. Sgt. Jessica Trimboli stated she is proud of the video and hopes to launch it via Teams with the group before it reaches the public.
- Caitlyn shared an update of the number of registrants for the upcoming National DEC Training. Jessica reviewed the purpose of the training and expectations of trainers.
 - Janice George requested information about the training to share with Northwest Florida Health. Theresa Schroeder shared it is difficult for representatives from the school district to attend the training since it is one week long and during one of the final weeks of the school year.
 - Jessica stated she will connect with Teri after the meeting to discuss this issue further.
 - Attendees discussed organizations that are not registered but should be. They identified law enforcement, fire department, Emergency Medical Services (EMS), and Department of Children and Families (DCF).
 - Emily will reach out to EMS, Jessica will contact law enforcement, and Danielle will notify Niceville Fire Department. Ashton Hatch shared she will contact her supervisor at DCF to identify a representative to train.
- Emily shared the High School Survey progress has been paused. The group is unable to work with SWAT on this project and it will be tabled until there is District approval to work with students.
