Opening - Emily Pickens

Action Plan Updates – Danielle Wilson Handle with Care

- Emily Pickens reviewed the following updates from Sgt. Jessica Trimboli:
 - Jessica shared Handle with Care will be in all Okaloosa County municipalities before the new school year begins. She wants to train everyone before school resumes to ensure all participating organizations are on the same page.
 - The group discussed who this may include, such as School Resource Officers (SROs), school mental health staff, local police departments, and other school district personnel.

Field Day Planning

- Head Start wants to partner to do a hand painting day with their children. Jessica will reach out for volunteers once a date is set.
 - She would like to begin planning an event for older youth in the near future. The plan is to partner with Emerald Coast Social Sports again for field day activities.
 She also hopes to partner with Big Brothers Big Sisters for the event.
 - Jessica also wants to begin doing fingerprint activities for children and their parents. Danielle shared this is something DEC had done in the past.
 - Attendees discussed upcoming events that members could attend to do the fingerprinting activities. This will be discussed more at the July meeting.

DEC Trainings

- Danielle Wilson provided an overview of the Drug Endangered Children training in May.
 - There are now 14 new certified DEC Trainers. 35 people received the DEC Awareness and DEC Approach training.
 - Danielle shared being a trainer is a rewarding, enjoyable experience. She and Jessica are both glad to have the capacity to hold DEC trainings more often in the community with the addition of new trainers.
- The group discussed future DEC trainings. Emily informed attendees that they should contact her, Jessica, or Danielle with any training requests.
 - Emily shared she can add a slide including information about the Handle with Care policy to the DEC Training PowerPoint.
 - The group also discussed adding Okaloosa County data to accompany the national statistics in the existing PowerPoint.
 - Danielle offered to contact DCF to obtain the most updated data.
 - Emily shared there was discussion in May about hosting a DEC Awareness training for the public, rather than a specific organization.
 - Danielle suggested it be held after work hours. The group agreed.
- Emily shared Emergency Medical Services and Public Safety will receive DEC Awareness training every Tuesday in July. Greg Cain will be requesting help from trainers soon.
