Purpose: Engage Okaloosa County community members in a health improvement process through an open, two-way dialogue to reduce the number of adults engaged in substance use.

Welcome & Introductions – Elizabeth "Beth" Smith

- Beth opened the meeting and welcomed attendees. She reviewed the meeting's purpose and agenda, she also reviewed results from the Community Engagement Survey from the previous meeting. 7 responses, positive responses. Attendees felt that there was good discussion, their opinions were valued, and there was enough time for all agenda items.
- Minutes from the October 9, 2023, meeting was reviewed and approved.

Action Plan Updates – Emily Pickens Pre-Arrest Diversion Discussion

- Emily Pickens opened discussion by informing attendees how the group was formed. Emily shared the group focuses on reintegration, but discussed in April how Okaloosa County has many resources for those who have already entered the criminal justice system. Therefore, members decided to focus efforts on providing resources individuals before and/or in the initial phases of interaction with the criminal justice system.
- Emily invited State Attorney Ginger Madden to share details on the new pre-arrest diversion (PAD) program in Escambia County.
 - Ms. Madden explained that the program is expected to launch in Escambia County on January 1st. Her office plans to implement the program into all counties in Circuit One. She explained Walton County is expected to follow Escambia next, with Okaloosa potentially launching afterwards.
 - Emily asked if they considered adding a behavioral health component.

- Ms. Madden shared if the program is successful in Escambia County, they
 may explore opportunities to incorporate behavioral health services in the
 future. This could potentially include anger management, drug
 counseling, or other services that would be appropriate for the charge.
- Ms. Madden emphasized that in the beginning the program will only be available to low level misdemeanors and nonviolent crimes.
 - Initially, the program will also be limited to first-time offenders, and there will be no fees other than the \$25 clerk fee and a cost of prosecution fee.
- She added that program roll out in Okaloosa County would include an emphasis on underage possession of alcohol, due to arrest trends.
- Ken LaPee asked if the program would be beneficial, as many of those arrests are tourists, rather than residents. Ms. Madden stated the program would be open to tourists. They will be required to pay the minor fees like other participants and would provide proof of community service hours from their state of residence. Staff from her office would follow up to ensure requirements are met.

Unite Us

- Ken LaPee expressed this program would not include a large majority of our homeless, mentally ill, and drug-addicted populations, as they would not qualify since many would not be first-time offenders. Emily transitioned discussion to Unite Us, as it would be applicable to all community members, including via self-referral.
- Emily reminded members that Unite Us is a referral system that serves as a guide of referring and tracking individuals for various community, medical, and social services.
 - She shared ideally, there would be a case manager in charge of making sure referred individuals are followed up with.
- Attendees discussed interest and benefits of the program. Ken LaPee and Larry McFarland questioned whether Unite Us would translate with the Homeless Management Information System (HMIS) or other existing systems.
 - Emily will inquire with the vendor.
- Emily asked organizations to share whether they find Unite Us to be beneficial, in order to move forward. Members agreed. Emily will work on next steps.

First Responder Briefings

- Emily shared the latest draft of the First Responder Briefings. The briefing includes a PowerPoint with community resources and a two-page handout with key information.
 - Jenna McElyea requested edits to their slides regarding Medication Assisted Treatment (MAT) versus detox.
 - Vanessa d'Aquin requested counseling services be added for slides regarding Crossroads Center. She emphasized Crossroads Center is free for patients.
 - Ken LaPee stated he'd love for the briefings to also be giving to the communication officers as well. Emily responded saying the group would be glad to share the information with anyone who is interested.
