MINUTES

Purpose: Engage Okaloosa County community members in a health improvement process through an open, two-way dialogue to create an environment with healthy and safe children, families, and communities free of the negative impact of substance use and drug activity.

Welcome & Introductions – Amanda Colwell

- Amanda Colwell opened the meeting and welcomed attendees.
- Minutes from November 15, 2023 were reviewed and approved.
- Emily reviewed the meeting's purpose and agenda. Amanda shared the results from the Community Engagement Survey from the previous meeting. The group shared they felt their ideas were heard and hope for better attendance in the future.

Action Plan Updates – Sgt. Jessica Trimboli & Danielle Wilson Run for Health Updates

- Amanda shared due to insurance issues, the run will take place in Crestview instead of Fort Walton Beach. Emily is working with staff at the city to determine a route.
 - o The proposed date is Saturday, April 6th. The run will begin at 8:00 a.m.
 - o Registration will be \$25 until the March 9, then it will increase to \$30.
- Attendees reviewed the t-shirt designs. They requested the colors be changed for the design to stand out more and for the graphic of the children to be larger.
 - o These edits will be made and shared with the group at a future meeting.
- Dana Hodges suggested adding a Field Day component to the 5K that the Early Learning Coalition will help manage.
 - This will be modeled similarly to Family Field Day the group hosted in November 2022. The ELC will bring a play area for little kids.
- Members also discussed recruiting food trucks to attend the event. Coffee, donuts, and other breakfast items will be available before the race.
 - Danie will work with Eglin Federal Credit Union to discuss a potential partnership.
- Amanda shared staff will meet with Active.com to discuss utilization of the platform for registration.
- Attendees suggested connecting with the Crestview Run Club and looking into a paid timing system like the Northwest Florida Track Club uses.
- Amanda will calculate the number of awards needed. Age groups will be broken up into categories by gender. Medals will be designed by the DOH-Okaloosa PIO as prizes.

 - Dana shared the ELC will begin doing VPK Round Ups soon and books could be given out then. Danielle suggested the CAC receive copies for their therapists.
 - o Teri will review the book and determine if any OCSD facilities could share them.
