Welcome & Introductions – Petra Maddens

- Petra opened the meeting and welcomed attendees.
- She shared Community Engagement Survey responses from the previous meeting. Attendees felt there was good discussion, their opinions were valued, and there was enough time. They wish there was greater participation from first responder agencies.
- Minutes from the previous March 7, 2023, meeting were reviewed and approved.

Action Plan Updates – Emily Pickens Opioid Intervention Program

- Emily explained the background of the post-overdose response team the group is developing. She shared details from the meeting Chief Bage held with Daytona Beach's Drug Abuse Response Team (DART) with new attendees.
- She shared they are meeting with another similar program run by Pinellas County soon. The program is managed by Jewish Gulf Coast Health Services and is more of a first-responder model than the previous program they met with out of Pinellas County.
 - She or Chief Bage will share updates at the next meeting.
 - They are still trying to meet with Escambia County EMS about the CORE program.
- Emily will continue researching peer models and action steps needed to develop this portion of the program.

First Responder Briefings

- Stephanie Wedel shared the responder briefings have gone well. She is still working to schedule Valparaiso Police Department and make connections with fire departments.
 - o Alex Winkler from Niceville Fire Department said they would be interested.

ODMAP

- Emily provided a brief overview of the ODMAP platform. It is designed to track responses to suspected drug overdoses and shows when Narcan was given. It is a useful tool, but reporting is not consistent across agencies.
 - EMS data is automatically pushed ODMAP via EMSTARS. All other data must be entered manually (i.e. law enforcement).
 - o Only first responder and public health agencies can access ODMAP.
- She shared a document with different views from ODMAP. It included county-wide hotspot mapping and more detailed maps of specific geographic areas.
 - o Attendees preferred the more specific maps that showed towns/municipalities.
 - Emily will request the maps be pulled as a monthly report to be shared at meetings moving forward. Attention will also be paid to quarterly trends.
- Attendees revisited Narcan resource QR code discussion from the previous meeting.
 The QR code would link to the Department of Health's website, like the community resource cards and Resource Briefing PowerPoint.
 - Bridgeway, Emerald Coast Life Center, and DOH-Okaloosa are willing to utilize the QR codes during Narcan distribution.
 - o Emily will develop the code and purchase copies of the printed sticker to share.
 - Stephanie expressed interest in distributing Narcan also. She will complete the forms required by DCF.

Unite Us

- Emily explained the purchase order was completed for the Unite Us Platform. Internal DOH-Okaloosa meetings will occur soon to begin implementation planning.
 - o Once that process is complete, a representative will reach out to non-profit and/or referral agencies with more information.
 - A meeting will be scheduled later to explain onboarding and linkage between existing systems like HMIS.
 - o Emily will provide more details as the project progresses.

Action Items - Emily Pickens

- Emily and Chief Bage will investigate other post-overdose response team models in Florida, including those that utilize peers or those with lived experience.
- Kat will share ODMAP reports with the group at the May meeting.
- Emily will develop the QR code sticker and begin the purchasing process. She will update other willing agencies once they are complete and ready for distribution.








STREET-VIEW HEAT MAPS




Bluewater Bay/Seminole






North FWB/Wright and Shalimar





SUSPECTED DRUG: HEROIN, OXYCODONE, METHADONE, SUBOXONE, FENTANYL


