Okaloosa Walton Housing Summit

- Melissa Garza provided a brief update about the Housing Summit for new attendees.
- Emily Pickens encouraged members to review the recently published Okaloosa County Attainable Workforce Housing Strategic Plan.
 - Elliott Kampert provided an overview of the plan's strategies.
 - Emily shared the Housing Steering Committee briefly discussed developing a media-based public education campaign following the Summit. This strategy overlaps with a strategy accepted within the plan. The Affordable Housing Advisory Committee will also be involved in the development of the campaign.
- Emily opened discussion regarding the development of the campaign.
 - Melissa stated the campaign should include educational pieces to combat key issues and include tailored messaging for different entities (i.e. public safety, local government, etc.).
 - Emily asked attendees if their agencies would be willing to participate.
 - Jason Fulghum will coordinate with OCSO, the Cities of Crestview and Niceville will assist, along with the Emerald Coast Association of REALTORS® (ECAR). Members then discussed other agencies to include:
