Welcome & Introductions – Petra Maddens

- Petra opened the meeting and welcomed attendees.
- She shared Community Engagement Survey responses from the previous meeting.
 Attendees felt there was good discussion, their opinions were valued, and there was enough time. They wish there was greater participation from first responder agencies.
- Minutes from the April 4, 2024 meeting were reviewed and approved.

Action Plan Updates – Emily Pickens Post-Overdose Response Team

- A Post-Overdose Response Team (PORT) Statement of Work was disseminated and reviewed by attendees. Emily Pickens explained the materials, described the team framework, and outlined implementation steps.
 - Larry McFarland stated they do not have licensed staff for the PORT, as they
 mostly have bachelor-level staff. Emily will update the verbiage.
 - Stevie Wolfe expressed the need for peer involvement. Stephanie Wedel explained she has advocated for adding peers and it will be included in Phase II

- of implementation. She and Emily will work to build a peer support network and develop relevant documents, trainings, etc.
- Lack of access to phones for follow-up interactions was addressed by the group.
 Potential resources include the Homelessness and Housing Alliance, Overdose
 Data to Action Grant, Federal Programs, Ealin VA Clinic, and Assurance Wireless.
 - Vanessa d'Aquin will task her staff with learning more.
- Attendees discussed required training outlined in the SOW.
 - Agencies who may have multiple people designated to the program on a rotating basis requested agency or section-wide training.
 - Emily and Chief Bage agreed it would be possible and can be tailored to the agency's needs. Trainings can also be recorded and reviewed if needed.
- Attendees reviewed the proposed outreach schedules. Option two was preferred, and Stephanie encouraged an 8:30 a.m. start time. Emily will update the times.
- Emily will work to develop an implementation plan with greater programmatic details.
 Chief Bage offered to pilot the PORT in Fort Walton Beach prior to the county-wide launch in July. Another meeting will be scheduled to plan for a mid-June pilot.
 - Other agencies agreed to a July start date. Feedback from the pilot will be reviewed with interested agencies and a roll-out schedule will be developed.

Action Items - Emily Pickens

- Emily will update the SOW and develop a full implementation plan for review.
 - o She will work with FWBPD, EMS, and Bridgeway to develop a program pilot.

Open Discussion - All

- Attendees discussed creating a version of the Your Life Was Saved Kits to share with the public. Emily's team will work to develop 'community kits' in the new fiscal year.
- Freedom Life Compass opened a second Freedom House location in Fort Walton Beach and moved their Spring Soiree to June 1st.
- FWBPD's next community bike ride is May 11th at The Landing beginning at 9:00 a.m.
