- Emily Pickens opened the meeting and welcomed attendees.
- She reviewed the meeting's purpose and agenda. She also shared the results from the Community Engagement Survey from the previous meeting. Results indicated meeting needs are being met.
- Meeting minutes from the July 18th, 2024 meeting were reviewed and approved.

# Action Plan Updates – JB Whitten & Robert Bage Pedestrian Safety Poster Contest

- The contest will be sent to all Okaloosa County School District schools, as well as homeschool families through email.
- The prizes will include a certificate signed by all the local mayors and a \$100 gift card.
   Mayor Whitten will utilize funds to cover this year's prize costs.
- Emily opened discussion for providing poster boards to schools to eliminate any financial barriers for families to participate in the contest. Catherine Card confirmed they would accept the posters and could be dropped off with contest flyers.
- Attendees discussed how to increase participation in the high school age group. Ideas
  included creating a challenge between high schools and focusing on marketing to the
  leadership classes to gain participation.

### **Protecting Pedestrians Videos**

- The protecting pedestrian videos from last year are located on the County's YouTube page. There are currently three videos. Meeting attendees discussed creating a new video to introduce at the press conference on October 3<sup>rd</sup>.
  - Video ideas included focusing on street parking and large parking lots.
  - o Devon will contact the other PIOs for assistance and determine what can be done in the given timeframe to create a new video.
- Pedestrian safety videos will also be played at OCSD schools during homeroom.
  - o Catherine suggested cutting a shorter video to accommodate for the time limit during homeroom. She and Devon will coordinate offline.
