Welcome & Introductions – Amanda Colwell

- Amanda Colwell opened the meeting and welcomed attendees.
- Minutes from September 17, 2024, were reviewed and approved.
- Danie Crowley reviewed the meeting's purpose and agenda. Danie shared the results from the Community Engagement Survey from the previous meeting. Attendees felt valued, and surveys showed strong participation, though more online input is needed.

Action Plan Updates – Danielle Wilson and Sgt. Jessica Trimboli

Handle with Care

- Danielle shared protocol is in place for Handle with Care with all municipal police departments. Amanda stated notifications have been slow utilizing the online form.
- Danielle added Rocky Bayou and Saint Paul Christian schools are being added to the notification list, and efforts are ongoing to contact private schools.
- Dana met with Superintendent Hughes from Walton County, who is supportive and requested Okaloosa County's point of contact to align efforts.
- Dana shared they have a provider training session scheduled for November 21st and would like training covering Lockdown and Secure procedures, Handle with Care, and Drug Endangered Children (DEC). DOH-Okaloosa will help coordinate.

Food Insecurity Project

• Claire noted Crosspoint Church will be contributing \$2,500.00 toward the lunch debt. A check will be provided to the ECCAC. More details will be shared when available.

Run4Health

- Attendees reviewed and selected a t-shirt design with the following changes: "Running through the Decades" in red, disco ball outline in red for visibility, and fonts updates.
- The group also selected a medal design and approved a flyer with the following changes: individual and group registration, best-dressed award, largest group prize, food trucks, health fair vendors, Crestview Community Center as the location and a website in addition to the QR code.
- Amanda mentioned that vendor registration form must include bringing a raffle prize.
- Petra will contact Annabelle's doughnuts, Frutas Locas, and Jeremiah's for food trucks.
