- Emily shared the Peer Role Description and application drafts with attendees. Members reviewed the documents and provided feedback.
- Members requested the following changes or updates to verbiage:
  - High school diploma, GED, or willingness to pursue it for educational requirement.
  - Must be 18 years or older.
  - Valid ID and own transportation required.
  - Must undergo drug testing and maintain DCF Level II background check.
  - Willingness to participate in weekend events and maintain a flexible schedule.



- Attendees discussed the need for a minimum participation commitment. Chief Bage and Stephanie suggested the following:
  - Event Peers: No hour requirement, volunteering is as needed.
  - Full Peers: 8 hours per month, with flexibility.
  - Members agreed failure to meet the 8-hour requirement would not be penalized if proper communication is in place, as flexibility is key in volunteer roles.

- Emily will complete edits to the application and Peer Role Description. She will develop MOA verbiage and a peer training plan before the January meeting.
