- Emily Pickens opened the meeting and welcomed attendees.
- Emily reviewed the meeting's purpose and agenda. Community Engagement Surveys from the previous meeting were positive, citing good collaboration.

Action Plan Updates – JB Whitten & Robert Bage

Pedestrian Safety Month Town Hall/Listening Session

- Mayor JB Whitten opened discussion regarding the development of a Pedestrian Safety Month Town Hall. He shared the purpose would be to solicit feedback from the community regarding traffic, pedestrian safety, and infrastructure priorities.
- After discussion, attendees agreed revisit planning this event in the summer due to other events and demands. The session will be held closer to Pedestrian Safety Month.

Opioid Educational Series

- Mayor Whitten shared the 2023 Drugs in Deceased Persons Annual Report was recently published. He shared key insights and trends showing a reduction of substance use deaths across Florida. Emily will share the report via email.
- Chief Bage provided an overview of the Educational Series purpose. It will be a smaller event than International Overdose Awareness Day and seeks to provide greater detailed data tailored to key decision makers and leaders in the community.
- Sessions will take place Tuesday March 11th and Thursday March 13th, one week prior to National Drugs and Alcohol Facts Week. Emily stated she secured the Crestview Community Center and is waiting to hear back from Crosspoint in Niceville.
